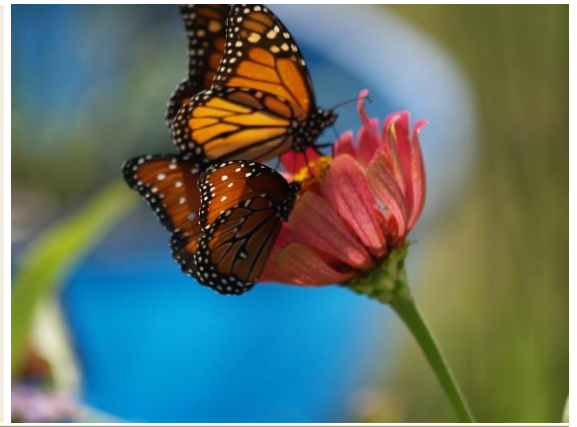

Sign-up started for 4H2O Youth Leadership Academy

4-H2O Youth Leadership Academy (July 21-28, 2018) The Leadership Academy is an educational tour experience exposing youth to a wide range of water resources, water uses, ecosystems, and water quality concerns. Ambassadors will learn about applied research and technology, water law, policy, planning, and management strategies employed to conserve this valued resource. As they meet and interact with leaders in the Texas water industry, Water Ambassadors will gain an appreciation for the complexity of managing surface and groundwater, and develop a broad perspective of the value of water to local, regional and state economies. Applicant must be 14 years of age or older as of August 31, 2018 and be entering the 9th, 10th, or 11th grades in the upcoming 2018-2019 school year. The cost is \$250 per student.

The District offers scholarships to eligible students in the District. We make an earnest attempt to fund as many students as fiscally possible. 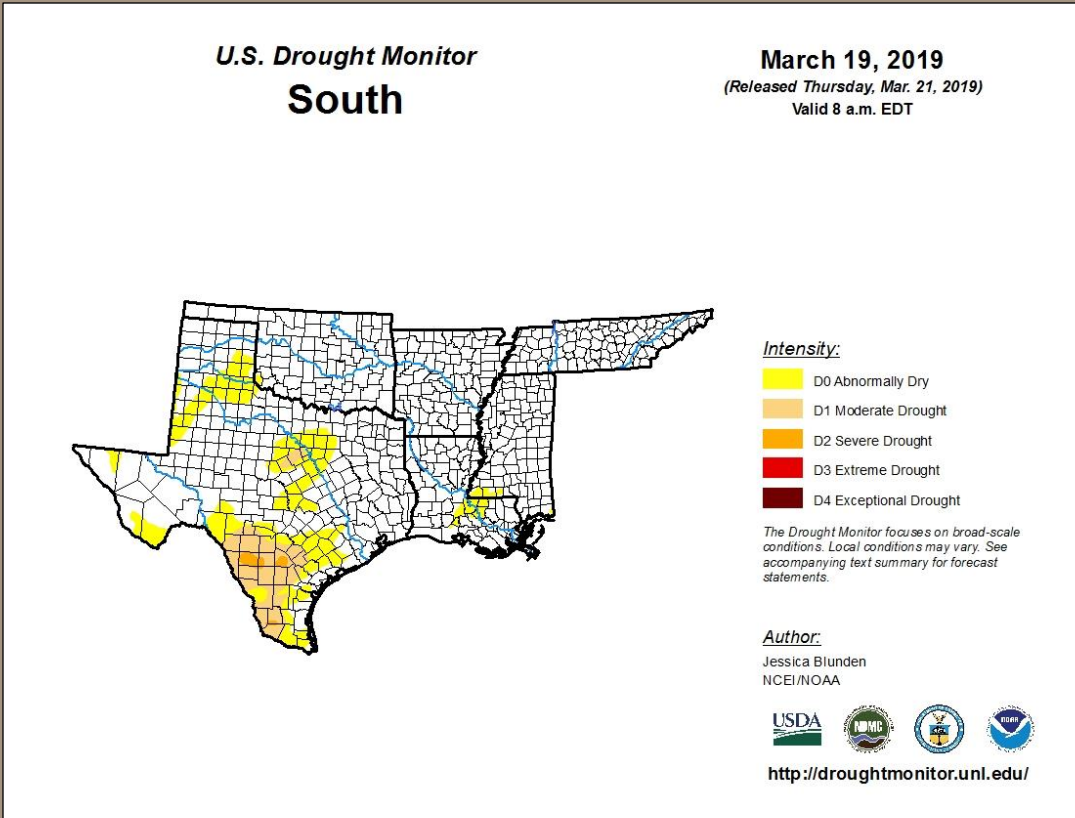

WellIntel Monitors soon to be active

The District has recently purchased and will soon deploy several acoustic water level monitors. These systems designed by WellIntel utilize remote telemetry and a cloud platform to collect groundwater measurements. We will be able to monitor fluctuations in real time.

Because we can watch fluctuations as they happen, we can begin to better understand the impact of rainfall and pumping on the water levels. From our office we will be able to monitor recovery rates as they are taking place.



Water Use Reports!

Water Use Reports were due March 15. Not everybody has submitted their paperwork yet. Please, even if you did NOT irrigate, file your Water Use Report with the District ASAP. Timely submission of annual water use reports is one of the requirements of keeping a groundwater permit active. Water Use Reports are required only for permitted wells...registered wells do not need reports filed.
