Water Use Reports

Every December, the staff at the Hickory UWCD mails out several hundred water use reports. These go out to everyone who has a permitted well in the District. We ask the well owner to list the wells and amount of water used during the past year. These forms are to be completed and returned to the office by March 15 of the year following the reporting period. According to District Rule 16, failure to timely file the annual report will subject the permittee to a civil penalty and other sanctions provided in these rules.

Groundwater permits are reviewed every three years for renewal. If a well owner has not submitted his annual usage reports, his or her well permit is

subject to cancellation.

Pressure is being placed upon groundwater districts to limit the total amount of water permitted from each aquifer. As caps are reached, permits will be reduced or recalled. The first permits to be cancelled will be those that have not met administrative requirements.

As with all data collected by the District, this information is not being gathered to infringe upon the rights of the landowner. Just the opposite is true. Accurate data will be necessary in the future to protect water rights. As the State tries harder in each legislative session to gain authority over

groundwater, the efficiency and effectiveness of groundwater districts will be under intense scrutiny. Proving we can manage groundwater at a local level will be imperative. Landowner cooperation will be a vital piece of evidence to support local governing.

Calculating Water Use

Understandably, people are confused about how to calculate the amount of water used. One method people use is to rely on their electric bill and calculate how many hours they ran the pump. Then take the hours and multiply by the average gallons per minute. Then take that number and divide by 5431.

Poster Contest


